- Vazduhoplovom se ne smije letjeti za namjene komercijalnog vazdušnog saobraćaja ili komercijalne operacije.
- *The aircraft may not be flown for the purposes of commercial air transport or commercial operations.*
- Maksimalan broj osoba koja imaju ovlaštenja da budu u vazduhoplovu tokom leta je određen kao minimalni broj lica koja su prijavljena kao neophodna za sigurno izvođenje leta.
- *Maximum number of occupants authorized to be carried is defined as the minimum number of persons declared necessary for the safe operation of the flight.*
- Zabranjeno je pušenje u vazduhoplovu.
- *Smoking in the aircraft is prohibited.*

Vazduhoplov se neće koristiti za letenje iznad urbanih cjelina, mjesta gdje se okuplja skupina ljudi, osim u mjeri koja je neophodna za prilaz aerodromu u skladu sa normalnom praksom vazduhoplova.

*The aircraft may operate in instrument Meteorological Conditions (MC) in accordance with Instrument Flight Rules (IFR) provided it is appropriately equipped for the purpose in accordance with EU OPS and Rules of the air.*

Vazduhoplov se može koristiti isključivo pod vizuelnim meteorološkim uslovima (VMC) u skladu sa pravilima letenja u vizuelnim uslovima (VFR).

*The aircraft may only operate in Visual Meteorological Conditions (VMC) in accordance with Visual Flight Rules (VFR).*

Ovaj vazduhoplov ne može letjeti u RVSM vazdušnom prostoru.
